1. The applicant should ensure the following:
 - (i) **MINIMUM EDUCATIONAL QUALIFICATION:** A candidate should hold a Degree in Civil Engineering from a recognized University/ Institute on the closing date of receipt of online application.
 - (ii) **MINIMUM ESSENTIAL QUALIFICATIONS:** All applicants must fulfill the essential requirements of the post and other conditions stipulated in the advertisement. They are advised to satisfy themselves before applying that they possess at least the essential qualifications laid down for the post. No inquiry asking for advice as to eligibility will be entertained.
 - (iii) **AGE: Not exceeding 30 years** as on closing date of advertisement. The Upper age limit for advertised post on direct recruitment basis is relaxable as per Govt. of India rules applicable for different groups/category.
 - (iv) **ELIGIBILITY FOR AVAILING RESERVATION:**
 - A) A candidate will be eligible to get the benefit of community reservation only in case the particular caste to which the candidate belongs is included in the list of reserved communities issued by the Central Government.
 - b) The OBC candidates applying for this post must submit OBC (Non-Creamy Layer) certificate issued during the year **2023 – 2024**.

- c) Further the OBC certificate should also clearly indicate that the candidate does not belong to creamy layer as defined by the Government of India for applying to posts and services under the Central Government.
- d) A candidate will be eligible to get the benefit of the Economically Weaker Section (EWS) reservation only in case the candidate meets the criteria issued by the Central Government and is in possession of requisite Income & Asset Certificate based on income for Financial Year (FY) **2022-2023** issued after **01.04.2023**.

- k) The Persons with Benchmark Disability (PwBD) candidates should possess a latest Disability Certificate issued by a Competent Authority certifying that the degree of disability is not less than 40% of the specified disability. Such certificate shall be subject to verification/re- verification, as may be decided by the Authority.

- (v) **Selection process:** On the basis of final merit (Written Test & Personality Test) in Engineering Services (E.S) Examination (Civil), 2023 conducted by UPSC.

NOTE : The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be considered for appointment or interview.

- (vi) **Service Bond:**

All selected candidates, at the time of their joining the post in the Authority, will have to execute a Service Bond for an amount of **Rs.5.00 lakhs** for serving National Highways Authority of India (NHAI) for a minimum period of **3 years from the date of their joining NHAI**. In the event of their resigning from the service of the Authority before the expiry of the bond period OR in case of termination of their service on account of their misconduct within three years of their joining NHAI, such candidates will be liable to pay an amount of **Rs.5.0 lakhs** to NHAI.

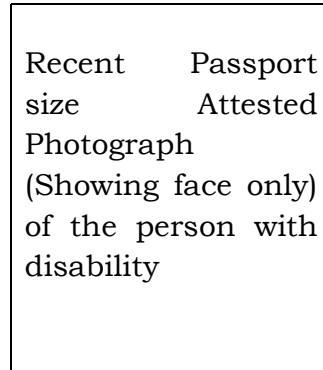
